## THE WEEK-END RESTORATION OF CRDER.

The non-Republican Press of Ireland reports in its issues of Nov. 27th and 29th the following acts of English Hillitary & Constabulary in Ireland:-

Murder of Donis Carey of Nenagh, Co. Tipperary, taker from his bed by constabulary and shot.

Imrder of Thomas Doyle of Dublin, shot dead in his home by Auxiliary "police."

Murder of Thomas Hogan of Dublin, fourteenth victim of the Groke Park battue.

Murder of Mortimer Luggan, teacher of Broadford, Co.Limerick, shot dead by military.

Murder of Denis O'Donnell of Kilderrery, Co.Cork, shot dead in friend's house by constabulary.

Attempted murder of Thomas O'Loughlin and Michael Loahy at Mullaunbrack, Co. Tipperary. Both were wounded.

Wounding of Patrick Halloran, John Witheroe (aged 19) and Patrick Keogh (aged 15) in Tipperary by military.

Bombs thrown indiscriminately in the streets of Mullingar by constabulary. Joseph McConnack (aged 15) seriously wounded. Business premises damaged.

Mill at Milford, Co. Cork, fired and destroyed by constabulary. Demago estimated at £15,000.

Carnadoe (Co. Roscommon), Co-operative Creamery fired and destroyed by Constabulary.

Temperance Hall at Kilmore: Sinn Fein Hall at Kilglass and a farmhouse fired & destroyed by constabulary in Co. Roscommon. Wholesale incendiarism in Cork City. Messrs. Forrests, Dwapors, and two other shops completely gutted on Saturday morning. Later the Recreation Hall at Douglan and the Parochial Hall at Blackrock (both suburbs of Cork City) were destroyed. On Sunday morning some of the most important warehouses in the centre of the City were fired and destroyed. Damage estimat od at £120,000.

They have their representative in the lobey of this House, I consider it a leathsome alliance that man whose hands are red with the blood of gallant soldiers and policemen should come into the lobby of this House and be allowed to circulate their badeous documents of falsehood..... I repeat that an organ prohibited by the law and used as a basis for newspaper reports condomning his Majesty's Government out of the mouths of those responsible for the marder campaign in Iroland is not a publication that ought to be accepted. I say it is a tainted source."
